We inform you that these parties are not at all affiliated with Trimegah, both in ownership and business. Therefore, all actions to offer financial/investment products/services of foreign exchange trading, and/or other than Trimegah's business registered in the Financial Services Authority (OJK) are not related to Trimegah.

Trimegah, the Management and employees are not responsible for any losses that arise/may arise in the future, both financial and non-financial losses, directly or indirectly/consequentially from the offering of the financial/investment products and/or services.

All use of logo, name and other information that is the same/resembles/mimics Trimegah with the aim of creating the impression that those parties are affiliated with Trimegah are actions that harm Trimegah, are misleading, can harm clients/prospective clients, business partners and the public, and can potentially be categorized as a violation of law that can be followed up by Trimegah accordance with civil and criminal terms with criminal sentence of a prison in maximum 5 (five) years and/or a fine of a maximum or Rp2,000,000,000 (two billion rupiah).
