

Trimegah and Bank DKI Signed Sales Cooperation Agreement of Retail Government Bond Series ORI014

Jakarta, September 11, 2017 – PT Trimegah Sekuritas Indonesia Tbk ("Trimegah") and PT Bank DKI ("Bank DKI") signed Sales Cooperation Agreement of Retail Government Bonds Series ORI014 Year 2017 for Rp50 billion.

The signing was conducted by President Director and Director of Trimegah, Stephanus Turangan and Syafriandi Armand Saleh, with Director of Finance of Bank DKI, Sigit Prastowo, witnessed by President Director of Bank DKI, Kresno Sediarsi.

The Retail Government Bond Series ORI014 will mature on October 15, 2020, with face value of Rp1 million per unit. Minimum subscription of Rp5 million and multiples of Rp5 million, and maximum subscription of Rp3 billion.
